- A community of persons with mental illness
- NorthStar follows the International Center for Clubhouse Development (ICCD) model of psychosocial standards based on Fountain House – "the gold standard for psycho-social rehabilitation."¹

• Core Principles

- A place to belong
- A place to return after any absence
- A place to find meaningful relationships
- A place to find meaningful employment

Mission Statement

NorthStar provides a safe and welcoming environment where members can participate in a peer-supported community, promoting independence, confidence, wellbeing, and recovery.

ICCD Standards – how NorthStar works

- Staff and members work side by side absence of hierarchy in management
- Work-ordered day work units/shared chores
- Community business partners employment opportunities
- Space a safe and welcoming but productive environment
- Collaboration with other community mental health services shared activities, cross-referrals
- Funding and governance

NorthStar programs

- Clubhouse Work: Members learn skills by providing voluntary employment at NorthStar through a workordered day
- Employment: Transitional, Supported, Independent
- Education: Tutoring, GED, Higher education
- Personal Goal Development: Short-term and lifelong goals
- Advocacy: Benefits including housing, social justice combating stigma, court system, health care etc.
- Outreach: Phone calls, emails, home visits etc.

Evidence for NorthStar

- Higher rates of employment, longer job tenure and and greater earnings²
- Reduced rates of hospitalization³
- Reduced likelihood of incarceration⁴
- Improved wellness⁵
- Comparative costs of services per person
 - Hospital 12 day LOS about \$12,000
 - Jail stay per year in Multnomah County = \$41,975⁶
 - Average cost per year of an ICCD program less than \$6,000⁷
