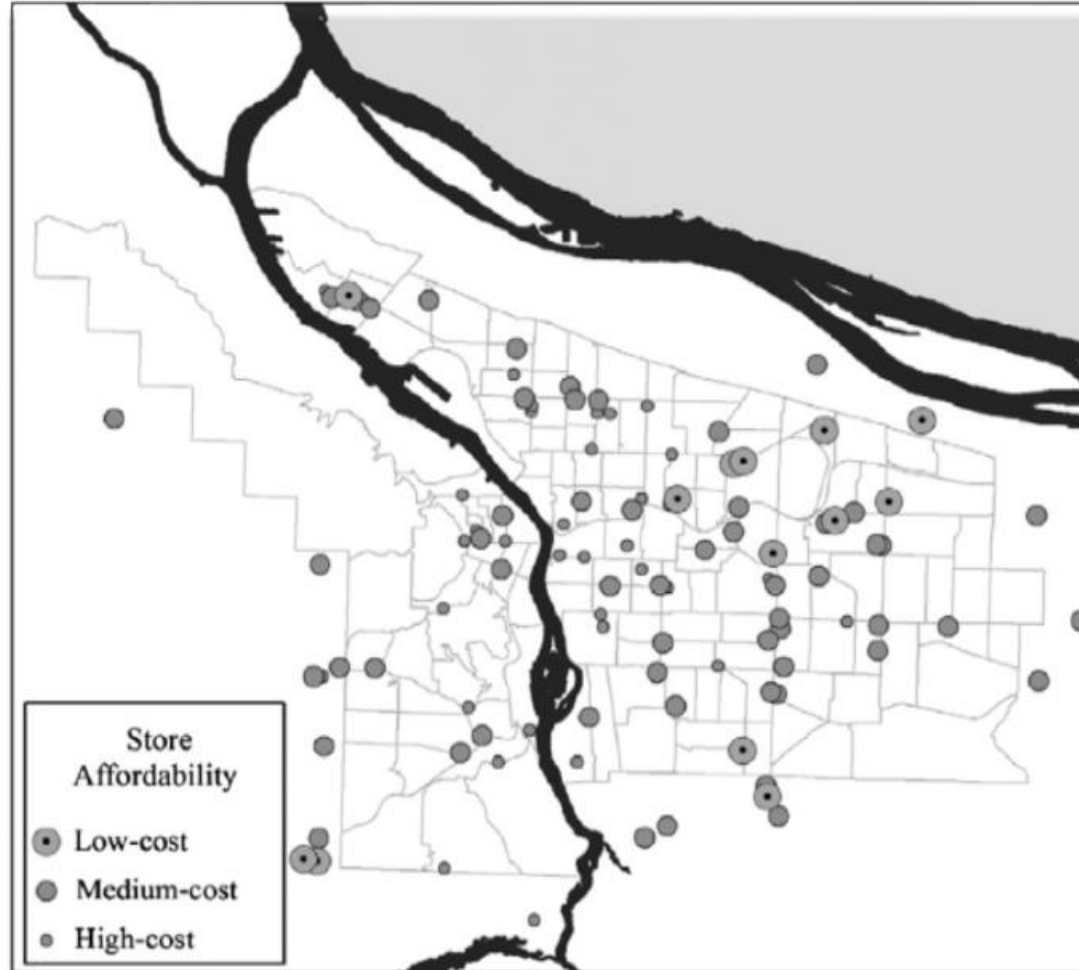

# Creating food equity: Food Mirages

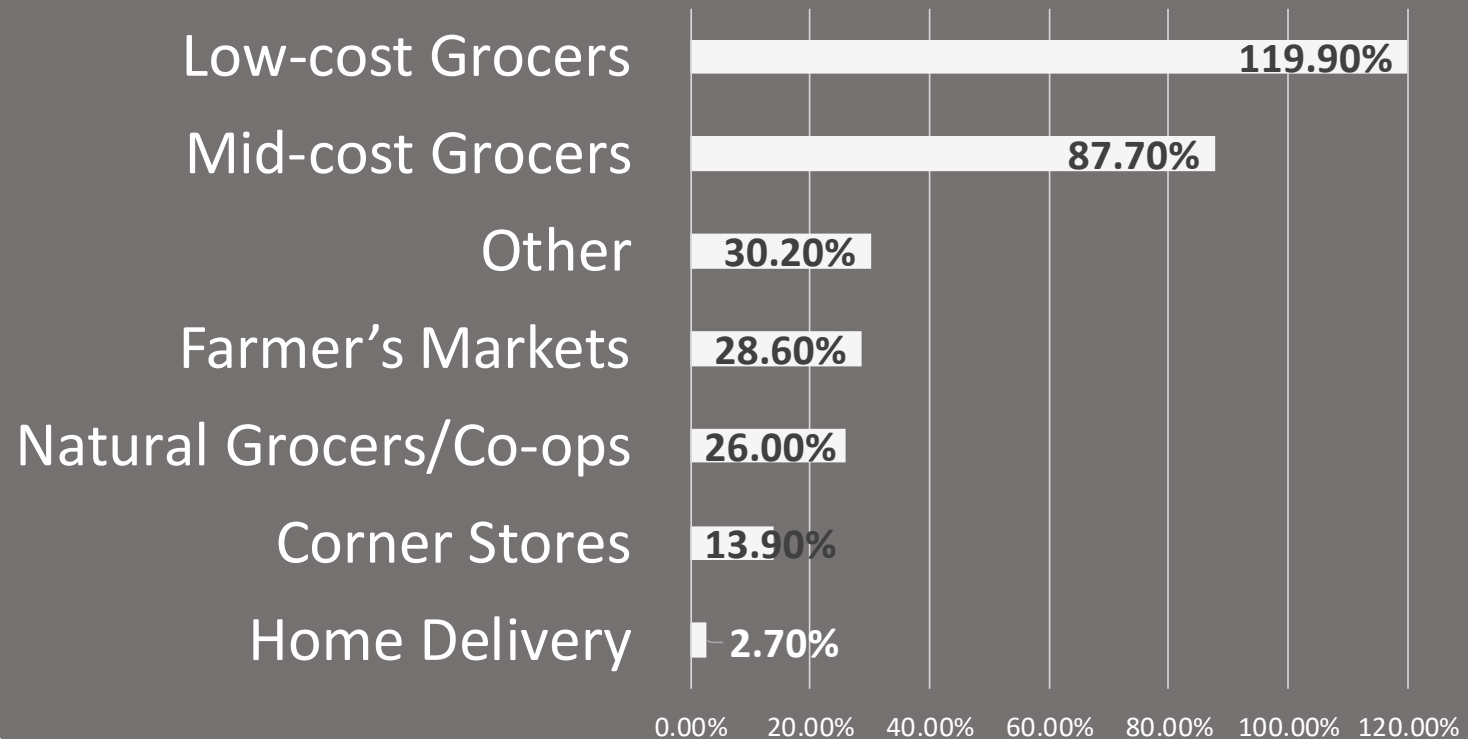

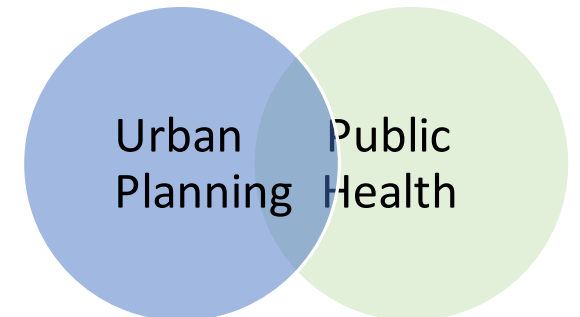
