We are very fortunate to have many volunteers

- Recognized all members of the board of directors, additional section leadership, and Kim Krull, OPHA Program Assistant
- This year wraps up the last of a three year strategic plan for the years 2012-14. OPHA has met and exceeded almost every goal.
  - Membership, conference participation, and the OPHA annual budget have all grown by over 50% in that time.
  - OPHA has formed and developed partnerships with many public health organizations throughout Oregon including those sponsoring and exhibiting at this conference.
  - Public Health week celebration activities continue to grow, including presentations, movie screenings, poster sessions, and a statewide online public health activity calendar.
  - OPHA has endorsed numerous bills and ballot initiatives and Capitol Visit Day grows in attendance each year. In 2014 there were over 140 attendees. Next year's Capitol Visit Day will be April 9, 2015
  - OPHA has greatly expanded its social media reach with the help of volunteer Lesa Dixon-Gray. Currently 1250 FB likes, 2000 Twitter followers, and 600 Linked in members.
- The board will be starting a strategic planning process right after the conference and have a finalized plan for 2015-17 by this spring. Members are welcome to give ideas
