- Fiscal year summary Most expenses will come through in November after the conference. We have less revenue than expected this year and slightly fewer expenses. We adopted a deficit budget in 2015 and have been using the reserve in a planned way for staff time and activities. We will have reserves for about 6 months at the end of this year and Jan recommends stabilizing the reserve there. If OPHA plans include expansion, revenue sources will need to be considered and methods to increase revenue should be included in the 2016 strategic plan. She encouraged donations, recruitment of colleagues, and attending the conference.

#### Review of OPHA's 2014-2015 Year – Jessica Nischik – Information

Josie Henderson resigned as OPHA's executive director in May 2015 for another position. Lila introduced Jessica Nischik as the interim executive director and recognized her for outstanding work she has done during a very active part of the year.
