### CALL FOR ABSTRACT SUBMISSIONS

**Abstract submissions are being accepted May 3 – June 18, 2021.**

**Please note:** You do not need to be a member of OPHA to present at the conference. However, presenters selected through the abstract submission process for individual oral presentations, break out panel discussions and posters must register for the conference, which includes payment. No exceptions will be made. Scholarships will be available.

**This year's conference will again be one of the most important ones we have ever hosted.**

Although all public health topics are welcome, this year OPHA is especially interested in abstracts about how the coronavirus pandemic has affected your work. Examples include: lessons learned, new partnerships, new communication methods, health impacts on vulnerable communities, health equity, access to care, changes in healthcare delivery, and methods/ideas/proposals/demonstrations of transformational improvements to the health of our communities.

**Submit abstracts for the following presentation formats:**

**Individual Oral Presentation:** Oral presentations are 10-12 minutes in length. Three presentations, grouped by themes, will be presented in each session. Additional time will be allotted for Q&A and discussion.

**Poster:** Posters are virtual, visual presentations in the final format of a PDF. The poster session is scheduled for **Monday, October 11**.

**Panel Discussion:** A panel discussion (75-minute program session) includes a moderator and/or discussant and up to three panelists/presentations (maximum four presenters). Due to time constraints, only a limited number of panel discussions will be accepted. Submit an overview abstract describing the overall purpose/theme of the panel and a minimum of **three** separate abstracts, one for each panelist. **NOTE: Panel submissions will only be considered if an overview abstract AND separate abstracts for each presentation are submitted.**

**Abstracts will be peer reviewed and accepted based on selection criteria.**
